Purcari Wineries Public Company Limited (the "**Company**") has been informed by Lorimer Ventures Limited ("**Lorimer**"), a wholly owned subsidiary of Emerging Europe Growth Fund II, L.P., managed by Horizon Capital, of Lorimer's agreement to sell a number of 4,539,233 existing shares in the Company in an accelerated book-building process (the "**Transaction**").


